#### Minutes of the Annual Meeting of the Board of Trustees

Wednesday, April 17, 2024

A meeting of the Cuyahoga Arts & Culture (CAC) Board of Trustees was called to order at 4:06 pm at the Cleveland Public Library, Louis Stokes Wing, 325 Superior Avenue, Cleveland, OH.

The roll call showed that Trustees Blakemore, DiCosimo, Isenhart, Mendez, and Scott Taylor were present. It was determined that there was a quorum.

Also in attendance were: Jill Paulsen, Executive Director and CAC staff.

#### 1. SWEARING IN OF TRUSTEES

Trustee Mendez stated that County Executive Ronayne nominated, and County Council approved, the reappointment of Karolyn Isenhart and appointment of Leonard DiCosimo to the CAC Board of Trustees. Trustee Mendez administered the oath of office for Trustees Karolyn Isenhart and Leonard DiCosimo. Each swore to honestly, faithfully, and impartially perform their duties while serving as a trustee of Cuyahoga Arts & Culture. Trustees Isenhart and DiCosimo were appointed to three-year terms ending on March 31, 2027.

#### 6. BOARD ACTION – GRANTMAKING

#### **Approval of 2025 Project Support Grant Guidelines**

Mr. Jake Sinatra, CAC's director of grantmaking strategy and communications, and Maya Curtis, grants manager, provided the Board with an overview of the 2025 Project Support Guidelines, which were included in the Board materials.

- Process changes are consistent with what was previewed in February 2024.
- There are no policy changes from the PS 2024 guidelines.
- Goals were to clarify and simplify language and processes.
- Maintain option for multi-year funding commitment (bypass) in this program.
- Program will launch in May.

Action: To approve the 2025 Project Support grant program guidelines.

Who are the panelists? Panelists for CAC grant reviews are artists and working arts/cultural administrators from across the county. Panelists are vetted by CAC staff.

#### 7. FINANCE REPORT

Ms. Meg Harris, CAC's director of administration, stated that tax revenue through March was \$1,907,440. This is \$374,255 (16.4%) below budget and \$529,249 (23.7%) below the same period in 2023. She stated interest revenue was \$130,013 and that non-grant expenses through March were \$233,279. Ms. Harris also provided an update on the status of the 2023 audit.

#### 8. <u>APPROVAL OF ACTION ITEMS</u>

#### **Appointment of members of the Audit and Finance Advisory Committee**

Ms. Harris said the purpose of this committee is to ensure CAC has proper financial controls and policies in place and that its investment of inactive monies complies with its Investment Policy. She requested the Board reappoint the current members of the Audit and Finance Advisory Committee to continued one-year terms: Luis Cartagena, Ann McCarthy-Garland, and Ken Surratt. She added that Dan Blakemore would serve on behalf of the Board.

#### Minutes of the Special Meeting of the Board of Trustees

Monday, April 29, 2024

A special meeting of the Cuyahoga Arts & Culture (CAC) Board of Trustees was called to order at 4:36 pm at the Cleveland Public Library, Louis Stokes Wing, 325 Superior Avenue, Cleveland, OH.

The roll call showed that Trustees Blakemore, DiCosimo, Isenhart, and Scott Taylor were present. It was determined that there was a quorum.

Also in attendance were: Jill Paulsen, Executive Director and CAC staff.

#### 1. BOARD ACTION - RESOLUTION FOR REPLACEMENT LEVY

Ms. Paulsen outlined a proposed resolution to Cuyahoga County Council for a replacement tax levy, noting the role of CAC's Board at this meeting is to determine the recommended timing and amount of the proposed tax.

Jeff Rusnak, Principal of R Strategy Group, and Jeremy Johnson, CEO of Assembly for Action, made a presentation to the Board regarding the recommendation for a replacement levy:

#### Arts & Culture Sector Economic Benefits

- Major contributor to regional economy
- Generates millions of dollars for region
- Creates and supports thousands of family-supporting jobs
- Attracts and retains talent
- Drives tourism
- Enhances neighborhoods
- \$533M in economic activity
- 8,637 jobs (AE6 Study)
- 104.2M in government revenue

#### Arts and Culture Sector Educational Benefits

- Improves student performance
- Offers unique opportunities and experiences for children
- Provides safe and healthy options for young people

Cigarette tax revenues have declined by more than 50% since 2007.

A replacement levy is recommended at the rate of 3.5 cents per cigarette for a period of 10 year.

This amount has been tested with voters and they are open to supporting a tax at this amount.

It is estimated that a replacement tax at this level will generate approximately \$160M over the ten-year levy period. This estimate factors in a continued decline in the sales of cigarettes in Cuyahoga County over the period.

Because this tax is specifically purposed for nonprofit organizations, work will continue, by Assembly for the Arts, to secure additional and different sources of funding to support independent artists. This is not the work of CAC but Assembly for the Arts.

# **Executive Director's Report**

September 11, 2024

Welcome to Cuyahoga Arts & Culture's September 11<sup>th</sup> Board meeting.

The meeting will start with the swearing in of CAC Trustee Gina Vernaci, who was formally appointed to our Board by County Council earlier this summer.

We thank Gina for her willingness to serve our agency and the residents of our County. As a reminder: CAC's five board members are uncompensated and serve three-year terms. While CAC is an independent political subdivision of the State of Ohio, Cuyahoga County nominates and confirms all CAC Board members.

Today's meeting will include an update on our **Grantee Connect Series**, CAC's initiative to listen more deeply and connect with our grant recipients to inform our grantmaking. The project included:

- CAC's first completely anonymous survey of grant recipients, with an impressive response rate from 75% of the cultural organizations we fund.
- Five listening roundtables co-hosted at arts organizations across the County.

In all, more than 280 people participated. We look forward to sharing with you what we learned and how we are already acting on the feedback.

While not on today's agenda, please see the Staff Report for details on the agency's efforts to highlight the **importance of public funding for the arts.** New ads and a fresh communications toolkit for grantees ensure that we're all telling the story of how public dollars distributed by CAC are funding arts experiences in every zip code for all county residents!

Finally, I call your attention to our agency receiving its 17<sup>th</sup> consecutive clean audit. We also earned the **Auditor of State's award**, an honor earned by fewer than 10% of public agencies statewide. I thank our entire team for playing a part in this achievement.

I appreciate your attention to matters before the Board today.

# **Updates from CAC Staff**

September 11, 2024

CAC's work is rooted in our <u>10-year community planning process</u> that identifies the two constituents that we must serve as: 1) nonprofit arts organizations; and 2) the residents of Cuyahoga County. Every year, staff creates a <u>work plan</u> that is grounded in this framework and CAC's <u>Mission</u>, <u>Vision & Values</u>.

What follows is a brief update on the progress made since the Board last met in April.

#### 1. GRANTMAKING

#### Core Grants: General Operating Support, Cultural Heritage, Project Support

2024 General Operating Support, Cultural Heritage and Project Support grants are in progress:

- General Operating Support: All grantees completed a 2024 Mid-Year Report, due July 31. Staff is working to review, provide feedback, and issue payments to grantees, which disburse 40% of the grant. New this year, grantees had the opportunity to schedule a site visit with their grant manager in lieu of completing written goal progress updates; 30 grantees participated, many expressing appreciation for the opportunity to connect. All grantees report on their goal progress at Year-End.
- <u>Cultural Heritage</u>: All grantees completed a 2024 Mid-Year Report and site visit or meeting with their grant manager, releasing 40% of their grant payment.
- <u>Project Support</u>: More than 55 Project Support grantees have completed their 2024 projects and completed reporting to date; the remainder are in progress. Grant managers process advance payment requests and reports on a rolling basis throughout the grant cycle.

To deepen relationships and hold more in-person meetings between CAC staff and grantees in 2024, grant managers are conducting regular site visits with their grantees, and the full grantmaking team is holding monthly team visits with a variety of grantees. Thank you to the grantees who have hosted our team throughout the year; we aim to continue this beneficial way of connecting with grantees into 2025.

#### 2025 Project Support

The 2025 Project Support grant program launched in May with an initial eligibility deadline in June. First-time applicants (15) and grantees eligible to bypass the full application and panel process in 2024 were required to submit a **full application** for 2025 and will be reviewed in the public panel process. Applicants who met specific criteria, are conducting the same project in 2025 as approved by panel could opt to **bypass** the full application and panel process and will automatically be recommended for a grant in November.

In total, CAC received a total of 221 applications for 2025 Project Support, as follows:

<sup>\*15</sup> of the 175 organizations being reviewed by panel are first-time applicants.

Of these applicants, 175 returning and new applicants will be reviewed through CAC's public panel in September. The remaining grantees have been previously vetted and are in good standing. They will be automatically recommended for grants at the November meeting.

• Panel Review Meetings: Forty arts and culture professionals have been recruited to serve as panelists who will evaluate applications to our Project Support grant program. All panelists have been trained and are reviewing applications. CAC's public grant review panels will be held virtually on September 16-18. Project Support applicants requesting up to \$5,000 are reviewed through a written panel process. All applicants receive detailed feedback from panelists.

#### **Technical Assistance & Grantee Feedback**

This year, CAC staff held a variety of in-person and virtual technical assistance opportunities and resources to help applicants and grantees succeed. This summer, those offerings included:

- Plante Moran: Understanding and Filing a 990 workshop
- Grant Opportunities Workshop
- SMU | DataArts Getting Started with the Cultural Data Profile and Data at Work: Introduction to DataArts Analytic Tools workshops
- Project Support application workshops
- Virtual application "office hours" for applicants to meet one-on-one with CAC staff to address their organizations' application and specific questions.
- Emails and personal phone calls regarding technical assistance and reminders fielded by the entire CAC team.

After each step in the grant cycle, **staff continue to collect feedback to inform our work**. Those who submitted feedback on CAC's application process indicated that they were "very satisfied" with the process. One applicant noted about our technical assistance offering: "Very useful - a lot of info given on what answers support the prompts." Staff use regular communication with applicants and grantees to inform technical assistance and to consider potential improvements for future grant cycles.

#### Grants to Nonprofits for Artist Support and Resident-Led Arts & Culture Projects

Assembly for the Arts' 2024 Support for Artists grant program is underway, supported by a \$500,000 grant. Assembly's design and management of the program includes a variety of project-based and flexible funding opportunities for artists, including programs by Cleveland Public Theatre, Julia de Burgos Cultural Arts Center, Karamu House, and SPACES, in addition to funding programs administered by Assembly. Assembly is also preparing to launch an artist advisory cohort, as part of the grant, to inform their ongoing artist programming. An announcement of the 2024 artist funding recipients is anticipated in September.

<u>ioby</u>'s CAC Match Fund leveraged a grant to provide dollar-for-dollar matching for projects that bring arts and culture to Cuyahoga County residents. The Match Fund concluded in July and leveraged \$80,000 in match funds to support residents to raise an additional \$92,449, for a total of \$171,889 directed to 38 local projects.

<u>Neighborhood Connections</u> is co-funding resident-led arts and culture projects in 2024 with a grant from CAC. The first "action grant" deadline was in February and CAC co-funded 27 approved arts and culture projects. CAC will co-fund a second round in 2024, the deadline was August 19 and applications are currently under review. Neighborhood Connections held its second of four Arts & Culture Network Nights


in 2024 on June 26 at The Brownhoist. The next Network Night is scheduled for Wednesday, September 25 from 6-8pm at Near West Theatre. All are welcome.


#### 2. COMMUNICATIONS

#### **Sharing the Impact of Public Funding**

CAC continues to create and promote tools for our grantees to tell the story of how public funding from Cuyahoga Arts & Culture has impacted their organization and community. These include:

- 2023-24 Report to the Community: In June, CAC released its 2023-24 Report to the Community in a digital and mailed print format. The report highlights CAC's grantmaking, including how public dollars we distribute help to boost the economy, educate children and teens, create experiences that enrich our lives, and enhance our community's appeal. The report has been viewed by hundreds of grantees, public officials, and other residents. View the report at 2023report.cacgrants.org.
- <u>Grantee Communications Toolkit</u>: In August, a new suite of free tools was released to grantees to help them acknowledge CAC funding. These include an updated suite of ads for print and digital distribution; a set of fact sheets; 50 CAC "swag bags" promoting ClevelandArtsEvents.com; a customized grantee messaging guide, with impact data and storytelling templates, and more. These tools have been well-received by grantees, who have already begun using them widely.





• <u>ClevelandArtsEvents.com</u>: Promotion of the Cleveland Arts Events website, where CAC grantees are required to post their CAC-funded programs and events, is yielding great results. Through August, the site has been visited by more than 63,000 unique users, a 5% increase over 2023. More than 1,900 events have been posted on the site by CAC grantees and other groups in 2024.

#### **Effective Teamwork and Operations**

#### Core Racial Equity Group (CREW) Updates

CREW is an internal advisory body to CAC for equity initiatives that lead to a more racially equitable workplace. You can find additional information in our <u>CREW Description</u>. CREW has finalized its 2024 goals, including an effort to encourage grantee organizations to share their demographic data via <u>Candid</u>.

Working alongside other Northeast Ohio funders, this effort would help to build a centralized, public location for reporting data and reduce reporting burdens on grantee organizations while furthering our understanding of the nonprofits we serve. As a first step in this process, CAC built an anonymous and optional self-identification survey for its own board and staff which was distributed in July. This process models what we anticipate for grantee organizations, and the data will be used over time to see how our own organization is evolving.

#### FINANCIAL UPDATE

#### 2024 YTD

**Revenue.** Tax revenue through July 31 was \$5,070,570. This is \$270,503 (5.1%) below forecast and \$780,794 (13.3%) less than the same period in 2023. The rate of decline in revenue is 13.3% YTD. Interest revenue through July was \$337,940. The overall expected yield on investments remained favorable due to sustained higher interest rates.

**Expenditure.** The majority of CAC's budget is comprised of grants which were approved in 2023. These grants are accrued at the beginning of the year and recognized on the balance sheet. Nongrant expenditures through July were \$582,550 and are tracking \$36,192 below budget primarily due to timing of payments.

**Investments.** As of July 31, CAC investment account balances are as follows:

- STAR Ohio: \$1,940,598 (yield 5.42%)
- RedTree Investment Group: \$9,473,270 (yield 4.36%)

#### **Audit and Finance Advisory Committee**

The Audit and Finance Advisory Committee met on May 22. The committee participated in the post-audit meeting with the Ohio Auditor of State (OAS). CAC's 2023 audit was released by OAS on June 4, 2024. The Auditor of State's Office awarded CAC with Auditor of State Award, an award in recognition of CAC's clean 2023 audit report. Fewer than 10% of the nearly 6,000 state and local government agencies that the Office audits each year receive this award.

Re: 2024 Grantee Connect Series Update

#### **Background**

In November 2023, Cuyahoga Arts & Culture committed to listening more deeply and connecting with our nonprofit arts and cultural community to help shape our grantmaking.

This commitment was made at a difficult time for our arts community. Many nonprofit organizations were continuing to grapple with uncertainties and budgetary constraints resulting from the pandemic. CAC made planned, but difficult, reductions to its grantmaking allocation as its revenues continued to decline. Concurrently, some artists were expressing discontent about how independent artists access funding.

Listening and evaluation have always been core to CAC's grantmaking process. However, we acknowledged that work needed to be done to build trust and unity so that CAC remains responsive to the needs of our grantees and residents, in 2024, and into the future.

#### **About the Grantee Connect Series**

In direct response to this commitment to listen and learn, CAC launched our *Grantee Connect Series* this spring. The initiative offered grantees a variety of ways to connect with CAC and each other. The series was designed to build transparent, trust-based relationships with our grant recipients that will better position CAC to respond to their needs and the residents they serve.

Our *Grantee Connect Series* offered staff and board members at CAC-funded organizations three ways to help shape CAC's work in 2024 and beyond:

- 1. **Guidelines Feedback**: an opportunity to provide real-time feedback on CAC's grantmaking guidelines for 2025 Project Support.
- 2. **Independent and Anonymous Grantee Survey**: a comprehensive, anonymous survey about CAC's grantmaking and future, managed by an independent research firm.
- 3. **Grantee Connect Meetups**: a series of in-person and virtual gatherings to hear the initial survey findings, share feedback, and connect with peers.

Additionally, CAC staff is conducting a **National Funder Scan**, interviewing representatives from more than 10 funding agencies (public, nonprofit, State, or local government). The scan will provide benchmark data and best practices which CAC can learn from as it plans for the future.

#### **Response & Initial Findings**

More than **280 individual participants** representing over **200 grantee organizations** participated in the *Grantee Connect Series*. Most of the participation came through the survey, which saw a 75% organizational response rate (185 grantee organizations) and a 58% individual response rate (218 completed surveys).

CAC staff held Grantee Connect Meetups at five locations, and in one online session. At those sessions we shared initial findings from the survey and gathered additional feedback.

#### Initial findings include:

- 1. Grant recipients highly value multi-year and flexible funding from CAC.
- 2. Grantees are satisfied with communications about the grantmaking process and find CAC staff helpful.
- 3. Some grant recipients do not understand how their grants are determined.
- 4. There is confusion about CAC's role in fundraising and/or diversifying revenues.
- 5. There is no consensus on how CAC should distribute funds or evolve its grantmaking, despite a shared need for more resources.

#### **Next Steps**

We have already begun acting on what we heard. For example, the survey indicated grantees are generally satisfied with communications from CAC. However, we heard grantees might benefit from new approaches to sharing information about CAC and its processes through videos, visual aids, and other tools. In August, we released a new Communications Toolkit, which aims to share in new ways. We also commit to:

- Continue the conversation CAC will continue its Grantee Connect Meetups, as an ongoing space to build trust and connection between CAC and the groups it funds.
- Offer ongoing feedback mechanisms CAC has launched a general feedback form to collect feedback from grantees and the public on a year-round basis. CAC has also increased its grantee site visits in 2024 and will continue to prioritize a variety of opportunities to connect with staff. Already this year, the grants team has conducted over 100 visits, an increase over recent years.

We anticipate sharing additional findings on this project later this fall, including methodology, results, peer research, and considerations for CAC's future grantmaking. These findings will inform Board planning discussions at future meetings, and the team's work as it begins development of 2026 grant guidelines.

# Methodology

In March 2024, CAC worked with an independent local firm, Bedrock Research, LLC, to administer an online survey of CAC's 2023-2024 grant recipients.

The objective of the survey was to **establish a** baseline of grantee feedback to help shape future planning and inform upcoming work.

CAC was provided aggregated survey data results and masked verbatim comments to protect respondent anonymity.


**75**% organizational response rate, **58**% individual response rate (**218** completed surveys received from **185** grantee organizations).


# How do CAC's application and reporting processes compare to other grants you pursue?




